**DARB RED CROSS SWIMMING LESSONS**

Registration must be received by Friday, April 4th. No registrations will be accepted on day of testing. Registration will be limited. Register early. A maximum of 15 participants for each class will be accepted. Swim Lessons begin with Level 1 this session. Minimum prerequisites include: Water entry, bubble blowing, front kicking, back floating, without assistance, and must be at least 5 years of age. Preschool will not be taught this session. Look for summer lessons at the outdoor pool for younger children.

**All participants - Please report to Derry Indoor Pool at 2:00 PM on April 5th for testing.**

You will be advised what time to report after that. Lessons are taught at the following times: Mon. and Wed. 6:30 PM and Sat. 2 PM, or Mon. and Wed. 7:30 PM and Sat. 3 pm. You will be informed what time to report after testing on April 5th. We will do our best to schedule more than one in family at the same time.

Spring Session: April 5, 7, 9,12, 14, 16, 21, 23, 26. No lessons on April 19<sup>th</sup>.
